- 1. Meeting called to order at 6:00 p.m. via Zoom.
- 2. Cady gave a quick review of the Annual Meeting Agenda scheduled for May 12.
- 3. April 13 minutes were approved.
- 4. Financial Statement/Budget (MK) See this item at the end of the minutes, after item #8.
- Leatherman Lowdown
 - a. Brian would like a Choral Tracks subscription in his budget. He wants to record everything we sing. His recommendation is to start recording now, particularly the Vaughn Williams piece, on this year's budget.
 - b. MK will need a few days to find out how much is left in this year's budget. She should have the answers by the end of the week.

6. Committee Reports

- a. Artistic (Margaret)
 - i. Margaret has typed up a list of duties and responsibilities for incoming chair Gloria.
 - ii. Margaret attended a webinar, whose theme was "How affected are choruses by COVID?" A doctor and scientist recommended 2 years before resuming. There is another webinar in June - planning for future crises. Margaret will advise the Board if she is invited to the webinar.
 - iii. Several moderators have choruses, and felt it was important to think outside the box, for example, if there is no venue for audiences, have a virtual concert? Rehearsals with temperatures taken, masks, gloves? Should this be new business for the 2020-2021 board? We will need explicit guidelines for CCC.

 - i. Brad, Mike and Cindy had a meeting last week regarding the website's need to be streamlined and modified.
 - ii. Brad is creating a series of Ad emails thanking sponsors, beginning with Tagawa.

7. Old Business

- a. June 8, 2020 Board meeting will again be a Zoom meeting.
- b. STAR doesn't have enough room to accommodate social distancing. If we tried to hold the meeting outside, we would need a covered venue.
- c. We will reassess this issue at the June 8 meeting.

8. New Business

- a. Kent reported that the SCFD face-to-face interview had to be cancelled due to COVID. Instead, SCFD sent out 5 questions. Kent has completed 3 responses, and needs the other 2 by Friday. He asked for input on these.
 - i. SCFD Question regarding minorities and ethnicities auditions with CCC. Kent would like to have a specific date to reach out. Suggestions were:
 - 1. Brian: is looking for partnership with Middle and High schools. He has talked to Overland, who has a diverse population. Choral scholars possibly?
 - 2. Young Voices?
 - 3. MK: target some church congregations with predominately minority individuals?
 - 4. Margaret: disabled groups?
 - 5. Nancy: solicit from Phamaly or Gay Men's Chorus?
 - 6. Lisa: collaboration is a good way. No token diversity.
 - 7. Kay: reach out to parents of performing students: i.e. Jewish Community Choir, with whom Marilyn Bogan is involved.
 - 8. Brian F: make a list of ethnically diverse organizations.
 - 9. Cindy: How much room is left in the chorale for more singers?
 - 10. Nancy wondered if a number of our singers will ask for a LOA. How do we handle this? Put this item on next month's agenda.
 - 11. Brian L: Auditions are July 28 and August 3.
 - 12. Kent would like to reach out by July 1. Brad, Kay and Margaret will help in gathering names of groups to appeal to.
 - ii. SCFD Question: How do we solicit feedback on performance and repertoire in a formalized process?
 - 1. Brian: what if we did one of our surveys in Google form (spreadsheet results) on Survey Monkey from both choral and audience members?
 - 2. Suggestion to have a survey after the Christmas concert biannually (every other year). Make this a purposeful survey.
- b. CCI wants to know about a 3-5 year plan
- c. Will there be a board retreat this summer? MK may have previous retreat information as a sample. Will we have a facilitator? What are we looking to accomplish or to address? This item will be put on old business for June 2020 meeting.

- 4. Financial/Budget (MK) (delayed from earlier in Board meeting)
 - a. We may need a special Board meeting before June regarding the budget. MK asked to each chair to say 1) what is really important, and 2) what we can trim.
 - i. Membership (Kay)
 - 1. Increase dues by \$5.00 per semester = adds \$1,240
 - 2. No scholarships = decreases \$190
 - 3. Refreshments: reduce to \$750
 - 4. Lanyards: purchasing 250 gets a price break. \$250
 - ii. Production (Brian F)
 - 1. Hall rental is \$17,530
 - 2. Recording we may have to go with the less expensive of 2 companies = saves \$4,000
 - 3. Could Cherry Tones find a different rehearsal venue?
 - iii. Marketing (Brad)
 - 1. Cost of \$1,000 for season brochures/cards. Snail mail vs. email?
 - 2. Look at Web posting expense.
 - 3. No more meals and entertainment?
 - 4. Audience attendance?
 - 5. Streaming and recording: ask for donations?
 - 6. Mike is looking to increase quality of stream recording vs. live stream.
 - 7. Can members purchase a recording vs. CD? That would reduce expense.
 - 8. Brian L suggested recording only 1 concert night instead of 2.
 - 9. Social distancing in October 2020: do not overestimate attendance.

iv. Brian L:

- 1. Suspend voice lessons.
- 2. Music storage has no budget increase.
- 3. Send out a survey to find out how many are singing a set or not.
- 4. Hired musicians: we can dispense with hired musicians in October = reduce by \$1.800.
- 5. March 2021: No Wild and Beautiful Orchestra? No organ? We could cut down to Ben and Ryan.
- 6. May 2021: Would Jacinda (Lone Tree Orchestra) be willing to let CCC hire her string players instead of union players?
- 7. We don't want to cut out everything wholesale. We need to keep quality.
- v. Development (Kent)
 - 1. SCFD funds were reduced 30% (down \$8,500).
 - 2. Grant funding is very tricky now.
 - 3. We need another corporate sponsorship.
 - 4. Members have been very good with Colorado Gives Day donations.
- vi. Outreach (Dan)
 - 1. This budget is bare bones.
 - 2. \$845 for security each concert weekend, which Board felt was important.
- b. Board will hold an additional meeting May 26, 2020
